

Privacy Statement

Kevin Bolton DEA has created this privacy statement in order to demonstrate our firm commitment to privacy.

These Web sites are owned by Kevin Bolton. As the central administration for the Web sites is based in the UK we apply UK law to the privacy principles. This Privacy Statement also applies to any other Web sites we may establish in the future, in any location, and which are not specifically named here.

Why We Collect Private Information

The Kevin Bolton DEA, contact and enquiry forms require users to provide private information (e.g. name and e-mail address). Kevin Bolton DEA uses this information to:

- send users information concerning Kevin Bolton DEA and its products, or its business partners and their products;
- Process payment for goods or services;
- Verify eligibility for access to secure areas of the site; and
- Contact the user when Kevin Bolton DEA considers that it is necessary to do so.

The Web Server upon which the Kevin Bolton DEA site is hosted also collects data such as your originating IP address or domain, the time of your visit, the pages you view, how long you stay, and other generalized information. This data is analyzed to generate statistical reports, which help Kevin Bolton DEA to detect traffic patterns and potential errors. This helps us to build a better Web site that is more useful and error free for our visitors. Except for tracing specific errors or malicious attacks upon the Web server this data is not analyzed to identify a particular person or entity.

Confidentiality Assured

It is the Kevin Bolton DEA policy that personal information is treated as private and confidential. Subject to disclosure to third parties, any personal information you may provide is stored in a secured location, is accessible only by designated staff, and is used only for the purposes for which you provided it (such as to reply to your inquiry or to handle your complaint).

Release of Information to Third Parties

Personal information will not be released to any other third parties (such as an Kevin Bolton DEA Business Partner) except to progress the matter for which you provided the information in the first instance unless the release of your personal information is required by law or is pertinent to governmental or judicial investigations or proceedings.

'Business Partners' are defined as Distributors, Resellers, or Channel Partners of Kevin Bolton DEA with each one delivering varying levels of goods or services depending upon their relationship with Kevin Bolton DEA.

The Kevin Bolton DEA Web sites may contain links to other, external Web sites. Operation of these links will not cause your personal information to be transmitted to these sites. Likewise, Kevin Bolton DEA cannot be held responsible for the Privacy Principles of other entities.

Security

This site has security measures in place to protect the loss, misuse and alteration of the information under our control. However, it is up to users of the demonstration area to be aware that this is a public site and as such any sensitive information should not be placed on the site and that any data placed in a public area should be removed by the user.
